Officer K.J. Durbin #14831, declares that he is a peace officer employed by the California Highway Patrol. That he has investigated a report of:

- ~~23152(a)CVC (DUI) - Misdemeanor~~
- ~~23152(b)CVC (.08% per se) - Misdemeanor~~
- ~~69 P.C. Threats to prevent a peace officer from performance of duty - Felony~~
- **422 P.C. - Threats to commit a crime resulting in death or great bodily injury ~ Felony**

That he on information and belief alleges and states the following to be true:

Durbin will say that on 10/31/2003, he investigated a male subject parked blocking a resident's access to the driveway, and urinating in public in a construction zone northbound Etiwanda Avenue, north of 58th Street.

Durbin will say that he contacted the Defendant sitting behind the steering wheel and was identified by a California driver's license (C5699711) which identified him as Alfred Beardsley with a DOB of 12-20-61. Durbin will say that he determined the Defendant to be the driver of the vehicle:

- His own admission
- Registered owner of the vehicle.

Durbin will say that he observed the Defendant was urinating in public. Durbin will say the Defendant gave his statement that he ran out of gas and couldn't move the vehicle. Durbin will say that he detected the strong odor of an alcoholic beverage emitting from the Defendant's breath and person. Durbin will say that the Defendant's eyes were red/watery and that his speech was extremely slurred. The Defendant refused to answer any sobriety questions or complete any field sobriety tests. Durbin will say that based on the Defendant's objective symptoms of intoxication he arrested the Defendant for violation of 23152(a) CVC per 40300.5 (b)(c)(d)(e) (CVC).

Durbin will say that the Defendant said he had a close friend who worked for the Los Angeles Police Department and would find out every detail about Officer Stephens and I within the next 6 hours.

Durbin will say that the Defendant hoped to find me off duty sometime, and if I would remove his cuffs so he could find out how tough I was.

Durbin will say that the Defendant was transported to Riverside County Central Jail and submitted to a blood test.

Witness, Officer D. Stephens (#15802) will say that while he was removing the Defendant from the patrol unit, the Defendant told Stephens he had a 9MM and that he would kill Stephens' family with the weapon.

Durbin will say that Officer Stephens informed him of the threat the Defendant made and that he was concerned and feared for his family's safety.

Durbin will say the Defendant was booked into the Riverside County Jail.

Durbin will say that he completed an arrest report (#200302638).

Durbin will say that the Defendant was the in violation of section 23152(a)CVC.

Durbin will say that the Defendant threatened to intimidate Officer Stephens and I to not carry out our duties required by law. A violation of 69 P.C.

Officer Stephens will say that the Defendant threatened to kill his family with a 9MM handgun; causing concern and fear for his family's safety.
A violation of section 422 P.C.


